INNOVATIVE RESEARCH

Our research is dedicated to a participatory action framework that empowers exonerees to lead and fully engage in all aspects of our research platform. This approach ensures that exonerees are not only involved but also influential in shaping the direction and outcomes of our studies.

In partnership with the Touro University California Public Health Program, our Virtual Reality (VR) for Exonerees Usability Study evaluates the effectiveness of VR technology, specifically mindfulness applications, in alleviating symptoms related to the trauma of wrongful conviction. This innovative approach aims to provide exonerees with practical tools for managing their recovery and enhancing their quality of life.

WOMEN'S RETREAT 2025

Women exonerees face unique, often overlooked challenges, particularly as mothers and caregivers. The trauma of wrongful conviction is compounded by the struggles of reentry—navigating the complexities of family dynamics, societal stigma, and the emotional toll of rebuilding lives for themselves and their loved ones.



Women make up nearly 15% of all exonerations nationwide, and their needs have not been adequately amplified or addressed. That's why we're hosting a first-of-its-kind retreat focused specifically on the needs, issues, and strategies for reintegration that women exonerees face. This retreat will create a supportive, healing space to center the voices of women, discuss their unique challenges, and empower them with the tools and community they need to rebuild and thrive.

Congressional Black Caucus Annual

When Innocence Isn't Enough.

Through these kinds of platforms, he has emphasized the urgent need for justice reform, highlighting the emotional, social, and economic toll wrongful convictions take on individuals and their communities.

Most recently, he was recognized as a Change Maker at the International Innovators 2024 Award Gala. Through his advocacy, Obie Anthony continues to educate the public, lawmakers, and other key stakeholders on the importance of systemic change and the need to hold accountable those responsible for wrongful convictions.
